**Guidance Notes for the Completion of this Form  
(Reference should be made to CAR OPS 1/3.890 and Appendix 1 to OPS 1/3.890)**

1. This Airworthiness Review document shall be completed and issued by the accepted Postholder for Airworthiness Reviews twelve months after the initial issue of the C of A and each subsequent CofA renewal.
2. An Airworthiness Review can be anticipated up to 60 days prior to the due date without loss of validity or periodicity.
3. The Airworthiness Review document must be raised in triplicate stating when the Airworthiness Review was issued. The copies shall be distributed in accordance with the following:
  - (1) One copy placed on board the aircraft/helicopter; and
  - (2) One copy placed in the aircraft/helicopter records; and
  - (3) One copy sent to the Authority within 10 days.
