## SAFETY NOTICE No. 04/2024 Issue 04

#### AIRSPACE OF LEBANON

Related: Safety Notices No. 01/2019 Issue 02

#### Introduction:

This Safety Notice is issued based on information currently available to the San Marino CAA in order to share information which is considered necessary to ensure the safety of flights over zones of interest and indicate areas of high risk.

The ceasefire between Israel and Hezbollah has reduced tensions between Israel and Hezbollah. However recurrent violations have been observed, primarily on targets near to Beirut International Airport during April and May 2025.

While residual risks remain and should be reflected in operators' risk assessments, it is considered that the approach starting from the sea and departure ending over the sea in cooperation with local air traffic control provides sufficient mitigation of the risk of misidentification.

The overall situation in the Middle East region remains volatile and should be closely monitored by operators.

In terms of airspace management, the State concerned has not demonstrated full capability to address existing airspace risks by implementing an efficient and proactive approach to the airspace deconfliction. As a result, there are limited mitigating factors, on which air operators can rely in the event of escalation.

Overall, there is a high-risk in the airspace of Lebanon, except for operations starting from the sea to Beirut International Airport and departures ending over the sea.

San Marino CAA will continue to closely monitor the situation, with a view to assess whether there is an increase or decrease of the risk for aircraft operators due to the evolution of the threat and risk situation.

FIR BEIRUT (OLBB), all altitudes
Applicability
Owners and operators of San Marino registered aircraft.
Recommendation(s):
The San Marino CAA recommends not to operate within the airspace of Lebanon at all flight levels, except for operations to Beirut International Airport (BEY / OLBA) under following conditions:
<ul> <li>approach starting from the sea / departure ending over the sea,</li> <li>coordination with local authorities and ATC, and</li> <li>based on continuous risk monitoring and an up-to-date risk assessment.</li> </ul>
Operators should closely monitor airspace developments and follow all available aeronautical publications concerning the region issued by Lebanon, or on behalf of Lebanon by the Aviation Authorities of the neighbouring States, including information shared through the European Information Sharing and Cooperation Platform on Conflict Zones.
